NSW Seniors Festival Expo 2026

TERMS AND CONDITIONS

General

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. The Promoter is HOMECARE GROUP PTY LTD (ABN 31 166 722 658) of 1/12 Cribb Street, Milton QLD 4064 (“Promoter”).
3. This promotion is conducted in New South Wales only.
4. This promotion is conducted at the NSW Seniors Festival Expo 2026 only.
5. NSW Authority Number: Not required (total prize pool under \$10,000).

Eligibility

5. Entry is open to individuals who:
 - Are aged 18 years or over;
 - Attend the NSW Seniors Festival Expo 2026 at which this promotion is conducted; and
 - Submit a valid entry during the Promotional Period.
6. Employees of the Promoter and their immediate family members (spouse, parent, child or sibling) are ineligible to enter.

Promotional Period

7. The promotion commences at 9:00am AEDT on 11 March 2026 and closes at 3:00pm AEDT on 12 March 2026 (“Promotional Period”).

How to Enter

8. To enter, eligible entrants must during the Promotional Period:

- Scan the QR code available at the Promoter's stand at the Attend the NSW Seniors Festival Expo 2026 at which this promotion is conducted or complete the in-person entry form; and
 - Provide their full name, email address, phone number and postcode.
9. Entry is free. No purchase is required to enter.
10. Only one (1) entry per person is permitted.
11. All entries will be collected centrally by the Promoter and subsequently allocated to participating Right at Home business locations in New South Wales for the purpose of conducting the draw.
12. Entries that are incomplete, illegible or received outside the Promotional Period will be deemed invalid.

Prize Details

13. The total prize pool is valued at \$1,400 AUD.
14. There are fourteen (14) prizes to be won.
15. Each prize consists of one (1) \$100 AUD gift voucher (voucher type determined by the Promoter).
16. The prize is not transferable or exchangeable and cannot be redeemed for cash.

18. Fourteen (14) separate random manual draws will take place at participating Right at Home business locations in New South Wales.
19. Each participating location will conduct one (1) draw at 3:00pm AEDT on 16 March 2026 at their respective premises in NSW.
20. Each draw will be conducted by the office owner or authorised representative in the presence of an independent witness.
21. One (1) winner will be selected at each participating location.
22. Winners will be notified by telephone within two (2) business days of the draw.
23. Prizes will be delivered electronically via email to the winner's nominated email address.

24. If a prize remains unclaimed within fourteen (14) days of notification, a redraw will occur at the relevant participating location at 2:00pm AEDT on 30 March 2026, conducted in the same manner as the original draw.
25. The Promoter will keep records of each draw in accordance with applicable NSW trade promotion requirements.
